- 3. For the period of 5 years from the date of purchase, Maxis Products Co. Ltd. "THATCH" warrants that the seller shall be responsible for the replacement of spare parts in case of missing parts or breakage (except color fading) during the warranty period.

CONDITIONS OF WARRANTY AND MAKING CLAIM UNDER THIS WARRANTY
